**Board changes – Seeing Machines announces new Chair**

Seeing Machines Limited (AIM: SEE, “Seeing Machines” or the “Company”), the advanced computer vision technology company that designs AI-powered operator monitoring systems to improve transport safety, announces that Kate Hill has been appointed Chair of the Board on a permanent basis, with immediate effect.

Jack Boyer OBE has resigned his position as Non-Executive Director with immediate effect.

As announced on 5 June 2019, Mr Boyer has indicated that current and future Directorships and other professional commitments have placed him in a position where he is no longer able to dedicate the requisite time, travel and energy to fulfil his role on the Board of Seeing Machines.
